Overview of costs:

For regular participation in one round only 265 Euro (in 2010) or 270 Euro (in 2011) will be charged. In the case that a certificate of participation (or Excellence) is ordered, 10 Euro (in 2010) or 15 Euro (in 2011) per certificate will be charged.

Additional costs may be:

- 1) Transport costs, including packaging, transport documents, customs clearance (when door-to-door delivery is needed), etc. These costs vary per destination, per transport type and per type of product. Consumer goods like textiles and plastics are usually sent via courier (DHL or FEDEX). In 2010, these courier costs are 85 Euro per dispatch. When possible sample dispatches are combined to reduce the transport costs.
- 2) For customs clearance in some countries a CoO (Certificate of Origin) is needed. This can be arranged, and 30 Euro per certificate will be charged.
- 3) In some countries a regulatory business tax or withholding tax is valid (e.g. 5% for P.R. of China). In those cases the costs per round will be increased to cover this amount.
- 4) Orders are accepted as completed and signed registration forms (hard copy or completed web site form), company purchase orders, service agreement bills or contracts. However, all our services are only executed in accordance with the latest version of the General Terms and Conditions of SGS Nederland BV filed at the Court of Rotterdam and in case a contract needs to be signed, additional administrative costs will be charged. These additional contract costs vary with the size and terms of the contract.
- 5) Credit card payments are accepted, but a handling cost of 5% will be charged.
- 6) Administration costs. Several companies require large administrative efforts from us for invoicing and/or contracting. The costs involved may be significant. In such cases administration costs will be charged.
